



**SEVEN NETWORK**

**TERMS AND CONDITIONS**

By entering the "Nissan Qashqai Lion King" **Competition** ("the Competition"), you are agreeing to the following terms and conditions:

**1. STANDARD TERMS**

- 1.1 Information on how to enter forms part of the terms of entry.

**2. WHO CAN ENTER**

- 2.1 Subject to clause 2.2, entry is open to residents of NSW, VIC and QLD 18 years of age or older. Entrants from each State will only be entered into the relevant draws for their State prize as stated in clause 5.1.
- 2.2 Employees and their immediate families of the Seven Network (Operations) Limited, Mnet Mobile Pty Ltd and their associated agencies and companies are not eligible to enter.

- 3.2 In order to enter the Competition, viewers must:
